Trading Commentary

The market recorded trading activity in **07** counters, namely, **FMB, MPICO, NBM, NBS, NITL**, **REAL**, and **TNM** during the week ending 08th May, 2015. A total of **7,406,419** shares were transacted during the week at a total consideration of **MK76,696,882.35** (**US\$173,972.72**) in 26 deals.

In the review period, the *Malawi All Share Index* inched upwards by 1.53 points to close the week at 16026.15 points due to an increase in the *Domestic Share Index* by 1.22 points from 12625.84 points to 12627.06 points as a result of share price gains in MPICO by MK0.30 from MK4.90 to MK5.20, and NITL by MK1.65 from MK48.35 to MK50.00, which was enough to offset a share price loss in TNM by MK0.05 from MK7.65 to MK7.60. The *Foreign Share Index* was steady at 1762.13 points.

At the auction held on 5th May, 2015, the average yield on the **182 days T-Bills** increased by **0.0801%** from **24.2911%** to **24.3712%** whilst the **91 days T-Bills** and the **364 days T-Bills** decreased by **0.6973%** from **24.11275%** to **23.4302%** and by **0.0608%** from **25.3299%** to **25.2691%** respectively.
